20 1. I, (First name, Initial: last name), declare that each of my statements herein are true, correct,  
21 and complete to the best of my belief and knowledge and stated under the pains and penalties  
22 of perjury under the Laws of the United States of America 28 USC 1746 (1) and the State of  
23 Washington laws.

24 2. I am over the age of majority and competent to contract.  
25

26 3. I have no known impairments limiting my right to contract, own property, or hold  
27 completely the rights to property.

1 4. I own myself and all energy created by my being of any sort, be it mental or physical and  
2 any combination of same.  
3

4 5. I have never knowingly with full disclosure agreed to grant property right to any part of me  
5 the man, (First name, Initial: last name), to anyone as an ownership position or capacity  
6 whatsoever.  
7

8 6. I am competent to read the English language and know how to use a dictionary.  
9

10 7. I understand what I read and was trained in the public school system to understand what I  
11 read.

13 8. I have read the original construction document creating the United States government, its  
14 Constitution 1787 as allegedly ratified 1789.  
15

16 9. I have read the Northwest Ordinance, 1 Stat 51, creating the Equal Footing doctrine  
17 authorizing other states to join the Original Confederated 1781 States in perpetual Union.  
18

19 10. I know the Equal Footing standing and capacity for Washington state predates the current  
20 U.S. Constitution and is binding on the United States now because Article VI of the U.S.  
21 Constitution states this fact as binding on all acts or omissions of the United States of America  
22 and the United States government corporation (28 USC § 3002 #15) inclusive of all its offices,  
23 officers, agents, or alleged assigns when they operate under color of official right claimed by  
24 the United States for any reason whatsoever.

26 11. I have read the Original 1787 Constitution of the United States of America.  
27

28 12. There is no authority granted by the States in Confederated Union, The United States of  
29 America 1781, to their constructed entity the United States as a government to contract with

1 me, (First name, Initial: last name), because there is no such contract power written into the  
2 U.S. Constitution for any purpose whatsoever outside the powers granted to it. The United  
3 States holds no power to attach me, (First name, Initial: last name), in any manner.  
4

5 13. I, (First name, Initial: last name), do not consent to any powers held by the United States  
6 government to detain me or my rights or attach me in any way whatsoever.  
7

8 14. I believe and will have evidence arising to proof of fact by deed that the United States in  
9 any of its disguises, the United States of America, UNITED STATES OF AMERICA, United  
10 States District Court for the Central District of Washington in any of their disguises, the United  
11 States Department of Justice, the United States Treasury and its entity Internal Revenue  
12 Service, under any of their disguises whatsoever, under any color whatsoever will be holding  
13 me, (First name, Initial: last name), to involuntary servitude, SLAVERY, when the authority to  
14 contract with me is not in evidence before the entire world and in my possession.  
15

16 15. I do not believe I may be forced to contract or be subject to any powers to which I do not  
17 consent under full disclosure of all relevant facts.  
18

19 16. I have read the State of Washington Constitution.  
20

21 17. There is no authority granted by the State of Washington as a government to contract with  
22 me, (First name, Initial: last name), because there is no such contract power written into the  
23 Washington State Constitution for any purpose whatsoever outside the powers granted to it.  
24 The State of Washington holds no power to attach me, (First name, Initial: last name), in any  
25 manner.  
26

27 18. I, (First name, Initial: last name), do not consent to any powers held by the State of  
28 Washington government to detain me or my rights or attach me in any way whatsoever.  
29

1 19. I believe and will have evidence arising to proof of fact by deed that the State of  
2 Washington in any of its disguises, Washington State, State of Washington, STATE OF  
3 WASHINGTON, under any of their disguises whatsoever, under any color whatsoever will be  
4 holding me, (First name, Initial: last name), to involuntary servitude, SLAVERY, when the  
5 authority to contract with me is not in evidence before the entire world and in my possession.

8 20. I am not and never could be the subject of government because the construction document  
9 for the entities the State of Washington, The United States of America 1781, the United States  
10 of America 1787 alleged ratified 1789, do not grant powers to subject anyone to anything.  
11

12 21. There is no power granted or gifted to any state or national or federal government to cause  
13 any of their officers or agents to believe I, (First name, Initial: last name), could be subject to  
14 their individual, official, personal, or collective powers because no such authority is granted to  
15 these individuals through the office they serve. Each individual serving in any government  
16 capacity whatsoever personally, in open public forum, before the entire world, pledge and  
17 promise each will operate within the limits of employers' constitutions.

19 22. There is no power gifted or granted to any government officer, employee, agent, or assign  
20 to interpret the powers constructing the office served or the execution exercises of authority  
21 when acting under color of official alleged right because such interpretations or expansion in  
22 any manner whatsoever the well defined, written in black and white authorities, does not exist
